Call for Papers: In a world where there is much animosity between individuals to entire nations, it is apparent that the current capitalistic world order needs to be replaced. In order to rebuild nations and create peace, a new world order is required with much emphasis placed on humanity rather than on material wealth. To this end, we believe the time has come to work steadily on a compassionate and fairer governance system based on legal principles emanating from Buddhist Philosophy, a philosophy which is essentially based on transforming mindsets irrespective of an individual's cast, creed, religion, nationality, ethnicity, richness or poorness and imperatively irrespective of whether the individual is a victim or a perpetrator. The 10th International Conference on Pāli & Buddhism on Buddhist Jurisprudence is setting forth the platform for Buddhist as well as legal scholars to embark upon this monumental task.

Authors are invited to submit either a 10-page short paper (presentation time 15 minutes) or a 30-page long paper (presentation time 30 minutes). The papers will be reviewed and selected to be presented at the conference and out of the papers selected for presentations, exceptionally well-written papers will be selected to be published in the conference proceedings. Please note that authors are required to submit papers under the sub theme of Community Restorative Justice.

**Virtual presentation facilities will be made available for presenters unable to attend in person Author guidelines for papers:

- A brief description of author (100–150 words) to be included in the paper (current affiliation and relevant recent publications etc.)
- Include 150-200 words abstract
- Identify 10–15 key terms for the index
- Include a 1–2 lines epigraph after the heading of the paper
- MS Word copy with double-spaced 12-point size font
- . A Unicode diacritic font, such as Times New Roman
- · Foreign language words (e.g., Pāli) should be italicized if not found in Oxford English Dictionary
- Paper should have in-text citations for references
- In addition to in-text citations if required use short endnotes (avoid long notes and footnotes)
- · Paper should include a complete bibliography of the works used
- Count the number of words and write down the counting after the bibliography (e.g., WC 3000 words)
